



## **SAFETY INSTRUCTIONS**

- Read the manual before use and keep it for future reference.
- Not suitable for pregnant women.
- Not suitable for people with epilepsy.
- Not suitable for people taking thyroid medication.
- After use, clean the device with a cotton cloth. Clean the device gently to avoid deformation and damage.
- · Do not use aggressive cleaning agents.
- Store the device in a shady and dry place. Store out of reach of the sun.
- Do not repair, modify, or use the device only for the purposes described in the manual. Do not store in extreme conditions or in direct sunlight.


## PRODUCT DESCRIPTION



## **USE**

- Clean and dry your face. Adjust the strap to the correct length.
- Make sure the battery is charged, or charge the battery via USB port (5V 1A)
- For a better effect, you can use a face mask or other cosmetics intended for the skin (lotion, oils).
- Wear a face mask for 10 20 minutes. The user can use the mask up to 30 minutes after ca. months of regular use.

- 1. Press the power button (2.) for 1 second. You can set the temperature, vibration frequency, LED light therapy.
- 2. Hold down the power button (2.) for 1 second to turn off.
- 3. Briefly press the power button (2.) to set the vibration.
- 4. Press the timer button (3.) to set the start time 10 min, 15 min, 20 min and 30 min.
- 5. Hold down the timer button (3.) for 1 second to set the LED light therapy. There are 7 types of therapy colors to choose from.



## **LIGHT THERAPY**

#### Red

Increased blood flow and collagen production. Helps with tissue repair (replacement of old skin cells with new ones) and pore reduction.

#### Green

Helps balance the color of the pigment, speed up skin regeneration and reduce oiliness

#### Blue

Soothing, anti-inflammatory, destroys skin bacteria

#### **Orange**

Energizes the skin, helps reduce wrinkles, balance the color of the pigment and smooth the skin

#### Purple

Helps prevent acne

#### Light blue

Helps increase cell energy and improve metabolism


## White

Helps improve skin tightness and tissue metabolism

## Eye care

The temperature of 40 ° C reduces dryness and eye fatigue. Softens circles and bags under the eyes.

## **ENVIRONMENT PROTECTION**

## TERMS AND CONDITIONS OF WARRANTY, WARRANTY CLAIMS

#### **General Conditions of Warranty and Definition of Terms**

All Warranty Conditions stated here under determine Warranty Coverage and Warranty Claim Procedure. Conditions of Warranty and Warranty Claims are governed by Act No. 89/2012 Coll. Civil Code, and Act No. 634/1992 Coll., Consumer Protection, as amended, also in cases that are not specified by these Warranty rules.

The seller is SEVEN SPORT s.r.o. with its registered office in Strakonická street 1151/2c, Prague 150 00, Company Registration Number: 26847264, registered in the Trade Register at Regional Court in Prague, Section C, Insert No. 116888.

According to valid legal regulations it depends whether the Buyer is the End Customer or not.

"The Buyer who is the End Customer" or simply the "End Customer" is the legal entity that does not conclude and execute the Contract in order to run or promote his own trade or business activities.

"The Buyer who is not the End Customer" is a Businessman that buys Goods or uses services for the purpose of using the Goods or services for his own business activities. The Buyer conforms to the General Purchase Agreement and business conditions.

These Conditions of Warranty and Warranty Claims are an integral part of every Purchase Agreement made between the Seller and the Buyer. All Warranty Conditions are valid and binding, unless otherwise specified in the Purchase Agreement, in the Amendment to this Contract or in another written agreement.

## **Warranty Conditions**

## Warranty Period

The Seller provides the Buyer a 24 months Warranty for Goods Quality, unless otherwise specified in the Certificate of Warranty, Invoice, Bill of Delivery or other documents related to the Goods. The legal warranty period provided to the Consumer is not affected.

By the Warranty for Goods Quality, the Seller guarantees that the delivered Goods shall be, for a certain period of time, suitable for regular or contracted use, and that the Goods shall maintain its regular or contracted features.

#### **Batteries**

6-month battery warranty – we guarantee that battery's nominal capacity does not fall below 70% of its total capacity within 6 months of the product's sale.

#### The Warranty does not cover defects resulting from (if applicable):

- User's fault, i.e. product damage caused by unqualified repair work, improper assembly, insufficient insertion of seat post into frame, insufficient tightening of pedals and cranks
- Improper maintenance
- Mechanical damages
- Regular use (e.g. wearing out of rubber and plastic parts, moving mechanisms, joints, wear of brake pads/blocks, chain, tires, cassette/multi wheel etc.)
- Unavoidable event, natural disaster
- Adjustments made by unqualified person
- Improper maintenance, improper placement, damages caused by low or high temperature, water, inappropriate pressure, shocks, intentional changes in design or construction etc.

#### **Warranty Claim Procedure**

The Buyer is obliged to check the Goods delivered by the Seller immediately after taking the responsibility for the Goods and its damages, i.e. immediately after its delivery. The Buyer must check the Goods so that he discovers all the defects that can be discovered by such check.

When making a Warranty Claim the Buyer is obliged, on request of the Seller, to prove the purchase and validity of the claim by the Invoice or Bill of Delivery that includes the product's serial number, or eventually by the documents without the serial number. If the Buyer does not prove the validity of the Warranty Claim by these documents, the Seller has the right to reject the Warranty Claim.

If the Buyer gives notice of a defect that is not covered by the Warranty (e.g. in the case that the Warranty Conditions were not fulfilled or in the case of reporting the defect by mistake etc.), the Seller is eligible to require a compensation for all the costs arising from the repair. The cost shall be calculated according to the valid price list of services and transport costs.

If the Seller finds out (by testing) that the product is not damaged, the Warranty Claim is not accepted. The Seller reserves the right to claim a compensation for costs arising from the false Warranty Claim.

In case the Buyer makes a claim about the Goods that is legally covered by the Warranty provided by the Seller, the Seller shall fix the reported defects by means of repair or by the exchange of the damaged part or product for a new one. Based on the agreement of the Buyer, the Seller has the right to exchange the defected Goods for a fully compatible Goods of the same or better technical characteristics. The Seller is entitled to choose the form of the Warranty Claim Procedures described in this paragraph.

The Seller shall settle the Warranty Claim within 30 days after the delivery of the defective Goods, unless a longer period has been agreed upon. The day when the repaired or exchanged Goods is handed over to the Buyer is considered to be the day of the Warranty Claim settlement. When the Seller is not able to settle the Warranty Claim within the agreed period due to the specific nature of the Goods defect, he and the Buyer shall make an agreement about an alternative solution. In case such agreement is not made, the Seller is obliged to provide the Buyer with a financial compensation in the form of a refund.
